The National Center for Responsible Gaming (NCRG) is a 501(c)(3) charitable organization devoted to funding peer-reviewed scientific research that contributes to the knowledge base about gambling disorders and leads to effective prevention and treatment of the problem. The NCRG, the largest private source of funding in the U.S. for investigations of gambling disorders, has been awarding competitive research grants on gambling disorders and youth gambling since 1996. The NCRG's mission also includes education and translation of research findings for the public, healthcare providers and others concerned about the impact of gambling.

The grants program is conducted under the direction of the NCRG's Scientific Advisory Board, composed of leading scientists with expertise in the addictions and related fields. The Scientific Advisory Board is committed to ensuring the most rigorous standards in the selection of projects funded by the NCRG. The Scientific Advisory Board and the peer-review panels follow the National Institutes of Health criteria for scientific merit and peer-review procedures.

The National Center for Responsible Gaming (NCRG) is pleased to announce the availability of research grants for the study of gambling disorders. The NCRG is committed to a multi-disciplinary approach and, therefore, welcomes applications from investigators in psychology, psychiatry, epidemiology, public health, sociology, economics, neuroeconomics, neuroscience and other relevant disciplines.

The NCRG's funding priorities include research on the following topics:

- Prevention of gambling disorders
- Outcome research on behavioral and pharmacological treatment strategies
- Decision-making and neuroeconomics
- The impact of new gaming technology on gambling and gambling disorders
- Gambling among minorities, especially Native Americans, and issues of health disparities
- Impact of DSM-5 changes in pathological gambling diagnosis
- Biogenetic vulnerabilities to gambling disorders
- Animal models
- Gambling among the elderly and emerging adults

Eligible applicants: Domestic or international, public or private and non-profit or for-profit organizations are eligible to apply for NCRG funding.
